



## Become a part of the **NOC NETWORK!**

Organizations, Businesses and Farms are invited to support the work of the National Organic Coalition by joining the **NOC NETWORK**. Because NOC does not get direct foundation dollars, we need your support to continue our work to ensure organic integrity. We will keep you informed and ask for your input to inform our work on organic issues at USDA, NOP, NOSB, other agencies (such as EPA, USTR, and Dept. of Commerce) as well as in Congress and the courts.

NOC hopes to increase its outreach to organizations interested in federal organic food policy by building a Network of Information and Action –

### **NOC NETWORK Participants WILL:**

- a) Be invited to our semi-annual “pre-NOSB” meetings,
- b) Get regular updates,
- c) Participate in occasional policy discussions via conference calls,
- d) Provide input into our 2012 farm bill agenda.
- e) Have the opportunity to ‘sign on’ to NOC positions (on an issue-by-issue basis)
- f) Be invited to join us for occasional DC fly-ins

### **NOC NETWORK Participants WILL NOT:**

- a) Be represented by NOC in lobbying activities in the Administration or Capitol Hill
- b) Be required to agree with all NOC positions
- c) Be automatically listed as supporters of NOC positions (unless asked on a issue-by-issue basis)
- d) Be “members” of NOC (see NOC Membership description)

### **Recommended contribution levels for NOC Network participants\*:**

Annual Operating Budget/Revenue less than \$500,000	\$250
Annual Operating Budget/Revenue between \$500,000 and \$1 million	\$500
Annual Operating Budget/Revenue over \$1 million	\$1,000
